2012 Brown County Fairest of the Fair Eligibility Requirements

- Contestant must be eighteen (18) years of age as of January 1 of the year of the contest.
- Contestant must have a valid Wisconsin driver's license with a good driving record.
- Contestant may not have been convicted of a felony act.
- The contest is open to individuals who have been a resident of the State of Wisconsin and Brown County for at least three (3) years prior to entry.
- Contestant must be available all days of the Brown County Fair (Wednesday August 15th - Sunday August 19th 2012) as well as in attendance at requested appearances and media interviews.
- The contestant agrees that the time, method, and manner of judging shall be solely within the discretion of the rules and regulations set forth by the Fairest of the Fair Committee and the Wisconsin Association of the Fairs and that the decision of the judges shall be final.
- If selected as winner of the contest, contestant agrees not to sign a management contract with any individual or corporation, give written or verbal endorsement, make a personal appearance for any mercantile commodity or commercial organization, nor permit any photographs to be used without the written permission of the Fairest of the Fair Committee.
- If I am named as the 2012 Brown County Fairest of the Fair, and for any reason do not fulfill the duties of this position for the entire term (one year), I will forfeit all cash prizes, scholarship monies, and other prizes that are awarded with the position. All of these awards will be returned to the Brown County Fairest of the Fair committee of the Brown County Fair.
- Contestants will be required to dress in business or professional attire, accompanied by the sash and crown, as well as act in a business professional manner, while promoting and representing the Brown County Fair.
- If I am named as the 2012 Brown County Fairest of the Fair, I will attend the Wisconsin State Fairest of the Fairs competition January 6-9th, 2013.
- If I am named as the 2012 Brown County Fairest of the Fair, and I am 21 years of age or older, I will not consume alcohol while on official duty as the Brown County Fairest of the Fair.
- The individual selected as Brown County Fairest of the Fair will not be eligible to compete in future Brown County Fairest of the Fair competitions.

I, _____, understand the above rules and if I am named as the 2012 Brown County Fairest of the Fair, I will abide by these rules. If I do not abide by these rules, I understand that the first runner-up will become eligible to be named the Brown County Fairest of the Fair per the Fairest of the Fair Committee and Fair Board of the Brown County Fair.
